Like so many cats, Candy lived an idyllic life, loved and pampered by her devoted person. But when her person developed dementia and could no longer care for Candy, the cat's happy life was upended.

It is difficult to find homes for older animals that are left homeless due to tragedy ... so, in many jurisdictions, a cat like Candy, or an older dog, would be euthanized. But not at RAPS. Because RAPS is a no-kill agency, we either find a forever family for animals like Candy, or they live their lives surrounded by all the love and attention they can want at the RAPS Cat Sanctuary, home to hundreds of unadoptable cats. RAPS Animal Hospital and onsite veterinarians provide all the medical care these cats require.

You can make a **Specific Bequest** by using the following wording in your will:

You can make a **Residual Bequest** by using the following wording in your will:

"I give to The Regional Animal Protection Society (charitable registration number #890733777 RR0001), _____% of the residue of my estate to help save and improve the lives of animals."
